Secret Service Counter Snipers are part of the Uniformed Division. The Special Operations Branch (Division) was formerly known as the Special Programs Branch, and was initially part of the Presidential Protective Division. In 2005 it became part of the Uniformed Division.

Special Operations Division (SOD)

The Special Operations Division (SOD) is composed of highly specialized units that directly support the agency's worldwide protective mission. [PSI Majority]: "So, for instance, there was counter sniper support. Were you made aware of that there would be counter sniper support the day of the rally, prior to the rally"?"

Asst. Dir. Plati: "In regard to counter sniper support, that was something earlier that week. I and my other DDS [Deputy Directors] had a conversation about. Two of my DADs [Deputy Assistant Directors], one whose particular portfolio the Donald Trump detail falls under, the other one, the Special Operations Division falls under. And we had a conversation where we felt moving forward, we wanted to authorize our CS support for this visit and outdoor rallies going forward."

[PSI Majority]: "And why did you make that choice?"

Asst. Dir. Plati: "Based on generalized reporting at the time, and due to the fact that we felt those outdoor rallies for the Former President were something that we've never seen a former president do in size, scale, and scope. On the cusp of being the nominee, it made sense to authorize our own CS, counter sniper resource, which is uncharacteristic due to the finite nature of the amount of counter snipers that we have.." [After Plati's counsel intercedes to remind PSI Majority about confidential information, and PSI Majority references the Iranian threat, that might be an assumption, then asks a clarifying question.} "Well, let me answer that question this way. I think some of this reporting at this point is now in the news. However, based in aggregate on the information that we were seeing at the time, I will say this, we were not in possession of any specific adverse intelligent to Butler. However, again I guess, I would rely on intelligence informs operations, but it doesn't necessarily dictate operations. And based on the totality of circumstances, we felt at this point being as close as he was to being, which we assumed, the nominee, that this was a prudent decision."







"The USSS Counter Sniper Team Leader told the Committee that when he initially took the photograph contained in the above [right] image, "I looked over at the AGR building, but I didn't really make a mental note of, hey, this is actually being blocked. It wasn't until later that I was actually doing the grids and doing a 360 that I went, I don't know if you can see that [the AGR building] from Hercules 2, so I make note of that at the time. But Hercules 1, you had a clear line-of-sight, so I was okay with it." ⁹⁴

When the Committee asked the USSS Counter Sniper Team Leader if he ever notified the Hercules 2 counter snipers about the tree line obstruction of the AGR building, he said, "I did not mention [to] them that hey, part pf the [AGR] building is going to be obscured from you." 95 When the Committee asked why USSS Counter Sniper Team Leader did not mention the obstruction to the Hercules 2 team, he responded:

Honestly, I just didn't think about it. This is one of the many threat areas that looked it (sic). I wouldn't have mentioned that hey, we can actually see the buildings on the left side, the private residences and the wood line, and you guys can't see that. It's kind of, between each posting, when we're working together we have full coverage, but there are certain things a certain post would see better than another post.."



"The way it occurred was- we both started scanning, looking for threats. [D, King] said, "I got him." I immediately gave him a wind call...So I gave him the wind call center, send it, basically don't make any corrections... From there I heard his round go off, and then I immediately -- I still couldn't find what he was shooting at, so I got off my gun and looked to see what angle he was looking at. "I was first hired by the Secret Service back in 2009, so 15 years [This leads me to believe he is Hercules 2a] ...I've been with the Counter Sniper Team since 2017, so 7 years...[Before being a CS] I was a firearms instructor and I also worked at various branches, to include the Vice President's residence and also the White House branch."



"My chain of command would be the supervisor who is there . We tend to put a supervisor on every trip that we have . But also the team leader who conducts the advance work would also fit into that chain of command . So typically information would go to him, the team leader, and that would be relayed to the supervisor who is on the trip, who then could relay back to D. C. or wherever if there was an additional supervisor on a detail."

When asked if he had "regular team member or partners, he replied: "It changes almost daily."



"When I was up on post with my partner, we noted several trees, several wood lines that blocked the three to four o'clock view of the AGR building, and we observed the crowd and the surrounding area. We received a BOLO, which is a "be on the lookout," and in that BOLO there were two photographs of an individual. I cannot recall who was the original sender of the email, but the team leader had forwarded it to all teams, all Hercules teams."



"But the next transmission that I heard was that a local was moving up to the AGR rooftop, and I went over the radio to say, "Send them up," because I did not know who had put that radio transmission over. And as I was observing, trying to spot this local on the roof, he all of a sudden emerged from the trees that were obstructing our view, and we followed him. We were worried about a potential blue-on-blue incident, because we knew that locals were in that area."

We continued to observe. We were trying to pick up on what the locals were actually working, but we couldn't figure out. And I'd like to say that the Security Room repeated my message back to me, saying that they had copied. And that's when I heard the first thud and a whip like crack, and I immediately went to my radio to say, "Hercules, shots fired." And I put that radio transmission over, not knowing who was shooting or what direction they were shooting in. But I knew I needed to trigger the emergency action of the shift on the ground around the protectee."


"I heard more cracks. I thought that my partner was hit, due to the proximity of these whip-like cracks and the impact report."

...

"And while we were at the hospital, we took a position on the rooftop, and my partner and I discussed the proximity of the rounds that were being fired at the site. And I asked my partner how close he thought the rounds were to our left, and he looked at me and said, "I heard them on my right." And they were approximately six feet between him and I when we were on the rooftop at the main site."







In the <u>letter to USSS Acting Dir. Rowe</u>, Sen. Grassley also included three photos provided to him by Butler County ESU showing a counter sniper nest(s) located in the two-story AGR building. The letter did not indicate which window(s) the photos were taken in. To some, the images appeared to be on the first floor, and too others they appeared to be three different windows. A detailed analysis was needed to determine which window(s) the photos were taken from. The following slides provide a summary of my analysis.







Sidebar Analysis – Counter Snipers

The second-floor windows have only a slight downward angle to the base of the trees. The first-floor window, which is slightly above the retaining wall, is level with the base of the trees.





The optical illusion seen in the windows appearing to be on the first floor are due to the building being located in a depression.

They are all located on the second floor.



Window 1: It is the only window that can see the multi-trunk tree to the west. You can even see some of the attendees in the window photo still at that time of the shooting, as denoted by the shirt-colored arrows. It's the west window.




Window 3: The same tree is seen in windows 1 and 3, as evident by the lower branch. People are not under the tree in window 3 due to time of day, based on shadow analysis. It's the west window.



The netting over the scope is also in the same position in windows 1 and 3, which means it wasn't disturbed at all between those two times.







Window 2: The cellular service tower building seen in window 2 can be seen from both the west and south windows. Given the angle from which the sniper took the photo, it can be a little difficult to determine which window it is. Further analysis was required.



Right Seen In Window







Window 2: Perpendicular to the west window looking out the cell tower building is 45° from the left. If you move 75° to the right the window appears at a 15° angle, offsetting the building by 15°, thus putting it at 60° from the left. It's the west window.

"A security operations plan had placed each of the three Counter Snipers inside of the building looking out of windows toward the rally, with none stationed on its roof. **Due to a lack of manpower, the men did not have spotters assigned to them**, as would be standard operating procedure." (Source: <u>Beaver Countian</u>)

"For more than five hours, the three snipers – Nicol, a fellow SWAT team member from Beaver County named Jason Woods and a third shooter from Butler County's SWAT team [later identified as Michael Murcko of Butler Township Police] – remained hidden in **their second-floor perch** without incident." (Source: CNN)

"A Butler sniper leader who met Nicol and his partners at the AGR building told them **their mission was to look out those windows and scan the area for threats, Nicol said**. **They were instructed to remain covert.** They set up their rifles on tripods so that the barrels were a foot or two inside the open windows to prevent them from being seen from outside." (Source: <u>CNN</u>)









Beaver County District Attorney Nate Bible and Det. Patrick Young, head of the Beaver County Emergency Services Unit:

"Where our people were was the far-right side of the AGR building. Their views in no way could have seen Crooks without pushing their heads outside the window and looking back," Young said.

"The snipers had been instructed to be covert, meaning they could not stick their heads out the window to see Crooks," Young said.

"The muzzles of the guns were about a foot behind the window," Young said, "and the snipers were about three feet back, observing through the window with binoculars."



Jason Woods: He is the Lead Sharpshooter for the Beaver County ESU team. He was only able to work until 4 pm the day of the rally, based on text messages during the buildup days before the rally. Upon leaving AGR 6 at approximately 4:26 pm, he alerted the other two AGR counter snipers of a new car parked where they had parked, and someone sitting at a nearby picnic table. This was initially believed to be the patsy, but was later revealed not to be.

Sgt. Gregory Nicol: He was the counter sniper who spotted and photographed the patsy, and later alerted the local counter sniper group, and even later, Butler County ESU command. **Cpl. Michael Murcko,**

Cpl. Michael Murcko: He and Butler Count ESU counter sniper Matthew Wagner, who was in the grandstands, were the only counter snipers who have not provided a public interview or testimony.



The Devil is in the details!

It would have been the boots on the ground, State and local law enforcement, who would have apprehended the patsy, not the ESU teams who had dedicated roles and positions.

Elapsed Time:

From when Nicol spotted a "Suspicious Person," it was:

- 28 minutes before tactical group informed
- 35 minutes before the BuC ESU got photos
- 41 minutes before State and locals got photos.

Shot 1 Countdown:

From when Nicol spotted a "Suspicious Person," State and local law enforcement had:

- Awareness with just 1/2 of the time remaining
- Photos with just 1/3 of the time remaining
- Command post got direction of travel with just
 1/6 of the time remaining
- Sheriff's deputies got direction of travel with just
 1/10 of the time remaining

Suspicious Person Reporting Analysis

When Nicol spoke about the photos he took of the patsy, he said: "The first thing I did, I sent those pictures out." (Source: ABC)



Fact: It was 24 minutes later, 5:14 pm to 5:38 pm, that he texted photos of a "Suspicious Person" to the 8-member tactical chat group. He sent the photos six minutes after he spotted the patsy using a rangefinder, making him a "Person if Interest."

It was 31 minutes after taking the photos when he sent a copy to command, and even then, one member of the tactical team prompted him to do that. When he did send the photos to command, he downplayed the importance it despite the patsy elevating to a "Person of Interest" by using a rangefinder, as standard threat level protocol would dictate.. He worded it as follows:

"{Redacted} if you wanna send this to whoever at command if you have cell number."


If you wanna? That doesn't sound like, "his assessment of the young man was elevated from simply odd to potential threat." (Source: CNN)

Despite the 31 minutes delay in sharing the photos to other law enforcement agencies, which Nicol was responsible for, he questions why those other agencies took so long.

"I assumed that there would be somebody coming out to -- you know, to speak with this individual or, you know, find out what's going on." (Source: ABC)

"I don't see any patrolmen or anybody outside looking for him," he told CNN. "It's like, what is going on here?" (Source: CNN)



Ben Shaffer: We could not connect him with a home police department, and judging by his testimony during the Congressional Forum, he may be a security consultant who maintains membership on the Washington Regional SWAT team..

Matthew Wagner: He and Butler Count ESU counter sniper Cpl. Michael Murcko, who was in AGR building, were the only counter snipers who have not provided a public interview or testimony. Other than the Butler County "FPOTUS Detail" plan, there has been no other evidence to corroborate that he was positioned in the east grandstand. He may have been in the west grandstand with Shaffer.



"At 6:02 p.m., the same local sniper who first radioed in the message about the range finder was on the second floor of the building owned by Agr International. From a northwest window, facing away from the rally site he glimpsed the suspect again just as Trump was preparing to take the podium?



Butler County ESU Officer's Testimony

During the September 26, 2024 Congressional Task Force Hearing, Rep. Clay Higgins reads a statement from Officer Aaron Zapolini, when questioning Butler County ESU commander Sgt. Lenz.

2:10:47 - "Commander [Lenz] I'm going to, I'm a quote from the uh transcribed interview of. Aaron Zaliponi. That's a tactical SWAT officer under your command that took shot number nine. He deploy, he was deployed, he heard the radio traffic, he saw the commotion, he left his deployed position, and ran into a position where he thought he might be able to get a shot on, if there was a shooter up on a roof, somebody on a roof. He said:

'Seconds after that is whenever the first three shots were fired. So, I hear the first three crack, crack, crack, and at this point I'm like okay where we at here. I look up that's when I see Crooks. I got his head, his shoulders, I can see a rifle at that point, I hear another crack. That's when I start pulling my weapon up. He gets three off as I'm getting my Target acquired. I'm getting my Red Dot up. I can see the gas emit from his barrel, his muzzle, then right after that I hear the snap of his fifth shot go off. Then immediately after that I press one off and that's when he immediately goes down. When I say goes down it wasn't like he was ducking to get out of the way, I mean I know I hit him like there's no doubt about it. He goes down, he kind of jerks to the right, and then he slumps over slowly, and then kind of slowly rolls backward out of my field of view. So, at that point I did not have a second shot at that point he tries to recover.'" (Source: Rep. Clay Higgins, Congressional Task Force Hearing.)
