The FBI stated having video evidence of the patsy at two points of time. First, he was sighted walking from his car back to AGR at 5:56 pm, after getting his backpack. Second, he was captured climbing onto the roof at 6:05 pm. The question is, what camera(s) did the FBI get that footage from? Knowing the location(s) would be helpful for some of my timeline analyses, hence this sidebar analysis.

The first order of business is to see what other evidence might exist that mentions the camera(s). It turns out there is one mainstream media article that mentions a location.

"Through analysis by our Evidence Response Team, or ERT, we believe the subject accessed the roof by scaling HVAC equipment and a pipe outside of the business."

"The next confirmed observation is at approximately 5:56 p.m., when the subject was seen walking in the vicinity of the AGR building carrying a backpack."

"I will now provide an update to the timeline associated with the subject's actions prior to the shooting."

Which camera(s) did the FBI get video evidence from?

NBC News published an article on August 27, 2024 citing an unnamed source. The ice cream shop near AGR is King Cone's Castle (KCC), located at 598 Evans City Rd, Meridian, Pennsylvania. It's located next door to Murdick's Auto Part and Pizza Pie, which share a building. King Cone's Castle has 3 security cameras (see red arrows), and Murdick's Auto Part and Pizza Pie has 1 on the side of the building.

Trump shooter believed to have used airconditioning unit to get on roof

Investigators were initially unsure how the shooter got a prime vantage point on a nearby rooftop on the day of Trump's rally.

"The source said video recorded from a nearby ice cream shop shows the shooter using an air-conditioning unit to climb onto the rooftop of a building to get into position about 450 feet from where Trump was starting his speech.

NBC News has not reviewed the video, and it is not clear whether it will be made public." (Source: NBC)



Peak Prosperity contributor @sorey asked contributor @Rough_Gypsy_Country (RGB) to take some photographs during one of his drone footage visits to help confirm whether or not King Cone's Castle had line of sight. From his first security camera search, he provided the following photos and comments:

"I checked all of the businesses along the west side of Evans City Road. Only two have security cameras. The first is King Cones Castle, **but all the cameras are angled downward into the parking lot.** The only one that would have a chance of recording the AGR property is the camera on the southeast corner of the building." RGB

Contributor @Rough_Gypsy_Country also provided the following photos and comments regarding the Murdick's Auto Part and Pizza Pie security camera:



"The second business with security cameras is the hardware/pizza shop. It has one camera mounted on the southeast corner of the building. It looks like a cheaper camera so not certain of its capabilities." RGB

That camera, if it even did have line of sight to the building, also had a large tree in the way.



Let's dig deeper. A little bit of research is needed to help understand whether or not the King Cone's Castle security camera could in fact capture the patsy in those locations. The field of view is dependent on the camera angle and lens size, and we don't know what that size is for their cameras.

Note: In the actual photo, above, the circle seen in the face of the camera is not all lens.





The focal length, or the size of the security camera lens, is the main factor that determines the Field of View. Camera with a larger size lens, produce a narrower Field of View and the shorter viewing distance. On the contrary, camera with a smaller size lens, also known as a wide-angle security cameras, produce a wider Field of View and longer viewing distance."

"A fixed lens is one where the camera's focal length is permanently set and cannot be adjusted by the user. This means that a fixed lens doesn't let you adjust the focal length so the **field of view** is permanently set, so it is important to select the correct field of view (wide-angle or narrow-angle) for your application. **Fixed lens** for **security cameras** are generally less expensive so can be a good option if the layout of an area is not likely to change (such as a room in a house).

These lenss are generally found as 2.8mm, 3.6mm, 6mm, 8mm, 12mm, 16mm etc. As shown on the graph, the larger the size of the lens, the more narrow and zoomed in the field of view is." (Source: <u>Dicsan - Cameras Field of View</u>)



Below is a crude approximation showing how important it is to know both the **mounted angle** of a fixed lens security camera, as well as the lens size and resulting **field of view**, to determine if it could capture the patsy on the roof of the AGR building when he accessed the roof. I do recall using the security camera shown on the left, while I was still working about a year and a half ago, and viewing security footage to try and capture a late-night vehicle theft in a parking lot to the right. The approximate field of view is shown. As I recall, the field of view could have included buildings ~550 feet away if I adjusted the camera angle upward. It was a varifocal lens (not a fixed lens) that allowed users to manually adjust the camera focal length, angle of view and level of zoom in the recorded video. I distinctly recall NOT being able to read a license plate in the parking lot close to the building, however.

Let's try a different approach. We have a video of sighting the patsy on the roof for comparison. Assuming the security camera has a little better focal length and resolution, I score the 6:05 pm sighting of the patsy on the roof from King Cone's Castle (KCC) a little higher. You'll have to decide for yourself where you score them.

The way the FBI referenced the source of the videos is different. The 6:05 pm source clearly suggests a security camera, and the 5:56 pm source sounds like a rally goer video. If a rally goer video, what first comes to my mind is the Jon Malis dashcam video, below.

The Pittsburgh Post-Gazette published their article on August 4th, after the FBI testimony, and used the time provided by the FBI instead of the video's timestamp.

During a 7/31/2024

NewsNation interview, it was reported that Jon Malis said his dashcam video was taken about an hour before the shooting. Between that and the timestamp it is clear that the FBI was either referring to a different video, or they got the time confused. He had no backpack in the video, which would highly suggest it was a different video.

In earlier versions of my analyses, I incorrectly thought that a light fixture next to Door 18 was the security camera that captured the patsy accessing the roof. Peak Prosperity contributors @AdudeUknow and @DAniel59 helped me "see the light." Pun intended. A higher

resolution screenshot revealed a light fixture turned sideways.



Initially I thought it explained the AAR 18:05-18:11 map redaction.



After that discovery, I went back to the same Spa Guy drone footage, this time using the highest resolution (lesson learned), to look for AGR security cameras again. I found two, one would have captured at the redacted location in the AAR 18:05-18:11 map, assuming it was the 5:56 pm sighting, but they were proven by Google Maps street view and BWC2-1222109 to be added after the rally.

The Horizon Farm Credit Union is the closest, but no security cameras are seen on the front of the building. If it had cameras, and the angle and field of view were just right, they would likely have an unobstructed view to Door 18, albeit at ~937 feet.



As RGB stated, "I checked all of the businesses along the west side of Evans City Road. Only two have security cameras. The first is King Cones Castle..." What is the second one? M&R Power Equipment has two, but they do not appear to point towards AGR.





Baglier Mazda also has one, but it points away from AGR. The business southwest of it has one also, but it's highly doubtful that it would capture AGR Door 18.

Using <u>Google Maps</u>, we can see from the AGR front entrance that there is visibility to businesses across the street from AGR's north side. Some are very close, while others are more distant. The greenhouses across the street do not have security cameras, at least not facing AGR. The same goes for the back wall of the Dollar General store. Zooming in all you can see are outdoor lighting fixtures on that wall.

The St. John's Reformed Church does not have security cameras, at least none on the side facing the AGR complex. As for Sheetz Gas Station, they seem to have more cameras than a Hollywood film studio. Thanks to contributors @RedRanAmber and @KINCSES Zsolt, I am including them in this analysis. When we were trying to confirm that the Hyundai Elantra parked across the street from the AGR main entrance was the patsy's, @sorey did a good job of locating the security cameras at Sheetz. I will analyze those facing AGR.

The first group of cameras to consider are located at the SW drive into Sheetz. When viewed from Meridian Road, you can see they face more to the west. If AGR was in the field of view, it is likely the Sheetz trees would be in the way, or given the ~1,200 ft distance would not have the resolution make out someone that far away.










The second group of cameras are on the west front wall. Two of the cameras are pointing west or northwest, not in the direction of AGR. The southwest facing camera is pointing more south, and would most likely not have AGR in the field of view. If it did, the line of Sheetz trees would obstruct it. The two cameras on the drive thru entrance sign would be totally obstructed by Sheetz's trees.









I stumbled upon this inconspicuous bit of evidence after Revision 3 of this analysis was published. It appears that the map presented during a segment of Rep. Corey Mills' testimony during the Congressional Task Force's September 26, 2024 hearing has a yellow notation point at the location of the King Cone's Castle SE security camera. That can only mean one thing, okay, two.

- King Cones Cast Whitestown Whitestown Rd
- 1) It is the security camera that captured the patsy at accessing the roof at 6:05 pm. It is also likely the camera that captured him walking back onto AGR grounds at 5:56 pm. It also means...
- 2) I now owe <u>@sorey</u> an ice cream cone. I'll gladly pay up!

Conclusion

It was the King Cone's Castle SE security camera!
